**Permission and Use of Club boats by members will:**

- Be on a ‘first come, first served’ basis and can only be booked by contacting Aileen Lennon directly on WhatsApp
- Books cannot be block-booked or booked more than one week in advance
- Requires sign out/sign in and stowage of parts
- Depends on the ability of the sailor(s), sea state, safety cover and weather
- Be secured **only** upon prior receipt of a signed application form and a signed parental declaration (if under 18) accompanying this application form

Return a completed **application form**, signed **parental declaration form** in advance of the sailing season. (Hand to either Aileen Lennon or Sergiusz Paprzycki before first use)

I acknowledge the right of the officers of Greystones Sailing Club, the Safety and Race officers to make all relevant decisions about matters relating to the sailing session including decisions affecting my child(ren)’s ability to sail in any given set of circumstances. I acknowledge that it is a condition precedent of my child(ren)’s use of the boat that I/he/she will at all time adhere to such direction as may be given to him / her by the Safety and Race Officers and I acknowledge the entitlement of the sailing club to exclude me /my child from participation in any aspect of the sailing session if it is deemed appropriate by them to so do

I agree to pay for any damage/loss caused to boats or equipment where I/ my child was

responsible for the damage/loss caused. I acknowledge that in the event of an insurance claim being necessitated as a consequence of the actions, accidental or otherwise, of me /my child any excess not covered by the sailing clubs policy of insurance will be discharged by me. I have read the sample price list of parts below which may fluctuate with the sterling/euro exchange rate and carriage costs.

I agree to rig the boat for inspection of parts and de-rig after inspection, ensure the parts are secure and stowed and the boat placed with the other Club boats in the Pen. Failure to do so may cause the Club to charge me for the cost of replacement parts that may be deemed necessary to put the boat back into general use. I have read the **GSC Safety on the Water** policy document (available online [www.gsc.ie](http://www.gsc.ie)) and agree to abide by it.
